EXHIBIT A Pursuant to Ordinance 12-4-2017A

PIONEER PARKRULES AND REGULATIONS

- A. Pioneer Park is open for use by the public on a daily basis.
- B. All events in Pioneer Park shall occur between the hours of 7:00 a.m. and 10:00 p.m. unless further extended by permit.
- C. Events to be held on Pioneer Park are scheduled through the City Clerk's office on a first come/first served basis.
- D. Events where alcohol will be <u>consumed</u> shall be required to obtain an alcohol beverage permit.
- E. City sanctioned, insured events where alcohol will be <u>sold and consumed</u> shall obtain a special event liquor license pursuant to the laws of the State of Colorado.
- F. City of Florence leash law (12.23.100) is enforced and all animal excrement shall be removed (12.24.090)
- G. No glass containers are allowed at any time.
- H. Sound levels of noise radiating from any electronic sources shall not exceed sixty (60) decibels at a distance of twenty five (25) feet from any source.
- I. No fireworks shall be allowed at any time.

EXHIBIT B Pursuant to Resolution No. 4 - 2012

FLORENCE MOUNTAIN PARK & AMPHITHEATER RULES AND REGULATIONS

- A. Florence Mountain Park is available for use by the public by permit or license agreement.
- B. Day use of Florence Mountain Park or the Amphitheater shall be between the hours of 7:00 a.m. to dusk.
- C. Events to be held at Mountain Park or the Amphitheater are scheduled through the City Clerk's office on a first come/first served basis. Applicant must apply for a permit at least two weeks prior to the scheduled event. Cancellation of event requires 48 hours notice to receive refund of fees.
- D. Events where alcohol will be <u>consumed</u> shall be required to obtain an alcohol beverage permit.
- E. The City of Florence leash law (12.23.100) is enforced.
- F. No glass containers are allowed at any time.
- G. No firearms, as defined at C.R.S. 30-15-301, or explosive or incendiary devices, as defined at C.R.S. 9-7-103, are allowed within the park except for certain organized, insured events by license agreement approved by the Florence City Council.
- H. No hunting is allowed within Florence Mountain Park but firearms may be transported through Mountain Park with obtaining an access permit to carry firearms to state and federal lands where hunting is allowed.
- I. Fires are prohibited in Mountain Park except in designated areas with fire pits unless conditions warrant a fire ban.
- J. Overnight camping is prohibited except by license agreement approved by the Florence City Council.
- K. All refuse shall be carried away from the park by the person or persons responsible for its presence.
- L. There are no sanitary facilities or potable water available in Mountain Park.
- M. It is unlawful to cut, remove, deface, injure or maim any tree or shrub in the park whether dead or alive.
- N. The City reserves the right to limit the number of persons at any event, or not allow the use of Mountain Park or Amphitheater area if an event is likely to cause concerns over public health or safety or if an event is likely to incite a riot or if it is in the City's best interest to close the park due to weather conditions or health concerns. The City will not discriminate against any group wishing to use Mountain Park, but preferences will be given to residents, businesses and industries in Florence. The City reserves the right, with justifiable cause, to impose further restrictions.

EXHIBIT C Pursuant to Resolution No. 4 - 2012

WILCOX PARK RULES AND REGULATIONS

- A. Wilcox Park softball fields were constructed to encourage outdoor sports in a controlled environment.
- B. Events held at Wilcox Park are scheduled through the softball league.
- C. Alcohol may be consumed at Wilcox Park by permit only to an individual who is at least 21 years of age or to an officer or agent authorized to apply for such permit on behalf of a legal entity organized under or recognized by the laws of the State of Colorado.
- D. A permit may be issued for social, fraternal, patriotic, political, athletic, religious or charitable events.
- E. Issuance of a permit may be denied upon the grounds that such issuance would be detrimental to the safety, health, morals, order or welfare by reason of the nature of the event, the likelihood, in the reasonable judgment of the officer of the city responsible for review and issuance of the permit, that the event would create a public nuisance or result in the consumption of alcoholic beverages by minors, or violation of any city ordinance or state law, its location within the community, or any failure of the applicant or permit holder in a pas event for which a permit was required to conduct such event in compliance with applicable laws and regulations.
- F. Issuance of such permit may be denied if another event has previously been scheduled for that location on the same day for which the permit is sought or if issuance of the permit would unreasonably interfere with normal activities and customary and general use and enjoyment of the location.
- G. Preference shall be given to residents of this city and to commercial and industrial enterprises located within the corporate limits of this city for use of public areas under the control of the city.
- H. Permits shall be valid only for the days specified and the request for the permit must be received no less than ten (10) days prior to the requested effective date.
- I. Permits are valid for the individual or entity to which they are issued and shall not be transferred.
- J. No issuance of a permit shall have the effect of requiring the City to issue such permit on any subsequent application.
- K. Issuance of an alcohol permit does not excuse compliance with any other requirements which may be required by virtue of the Colorado Beer Code and the Colorado Liquor Code as set forth in the Colorado Statutes.
- L. Issuance of a permit does not excuse compliance with all applicable statutes and ordinances which govern conduct which remain in full force and effect.
- M. The applicant for the permit must assure proper restoration and any required repairs of the park facility after the scheduled event to include, but not limited to, putting all containers in proper receptacles.

Exhibit C (continued)

- N. The applicant for the permit must sign a document indicting that he/she has read these regulations, understands them, will assure compliance with the same and bears responsibility for compliance.
- O. No alcohol shall be consumed prior to 10:00 a.m. or after 10:00 p.m.
- P. When youth leagues are playing no alcohol shall be consumed by spectators, officials or players.
- Q. No open container of alcohol shall be taken off the premises of Wilcox Park.
- R. No player shall carry an open container of alcohol onto the playing fields.
- S. City of Florence leash law (12.23.100 is enforced and all animal excrement shall be removed (12.24.090).
- T. Schedule of fees for use of Wilcox Park are on attached Exhibit E.

EXHIBIT D Pursuant to Ordinance 12-4-2017A

FLORENCE RIVER PARK RULES AND REGULATIONS

- A. Florence River Park is open for use by the public on a daily basis.
- B. All activity in River Park shall occur between the hours of 7:00 a.m. and 9:00 p.m. (dusk).
- C. Events to be held at River Park are scheduled through the City Clerk's office on a first come/first served basis.
- D. Events or activities where alcohol will be <u>consumed</u> shall be required to obtain an alcohol beverage permit.
- E. The City of Florence leash law (12.24.100) is enforced and animal excrement shall be removed (12.24.090).
- F. No glass containers are allowed at any time.
- G. No firearms, as defined at C.R.S. 30-15-301, or explosive or incendiary devices, as defined at C.R.S. 9-7-103, are allowed within the park.
- H. No hunting is allowed in River Park.
- I. Overnight camping is prohibited except for certain organized, insured events by license agreement approved by the Florence City Council.
- J. Fires are prohibited in River Park except in designated areas with fire grills unless conditions warrant a fire ban.
- K. Fishing is allowed during regular park hours. All state fishing regulations are to be followed at both the access to the Arkansas River and in the ponds within the park. Fishing on the Arkansas River access can be prohibited by the City Manager if dangerous conditions exist on the river.
 - L. All refuse shall be carried away from the park by the person or persons responsible for its presence.
 - M. It is unlawful to cut, remove, deface, injure or maim any tree or shrub in the park, whether dead or alive.
 - N. No unauthorized motorized vehicles are allowed beyond the parking lot.
 - O. Schedule of fees for use of River Park are on Attached Exhibit E.
